The Reorganization Meeting was concluded.

SOUTH PYMATUNING TOWNSHIP REGULAR MEETING

Brian Geisel announced that an Executive Session was held on December 24, 2013 at 9:30 AM to discuss personnel issues.

A motion was made by Brian Geisel and seconded by Mark Presley to approve the minutes of the December 11, 2013 Regular Meeting and to dispense with the reading of them. Motion passed unanimously.

Visitor Comments:

Ed Wilson said the supervisors were to have an answer for the fire department regarding giving them more money. Mr. Wilson wondered how the solicitor was chosen and what his rate of pay is. He is opposed to the police officer attending the meeting. Mr. Wilson said there was a semi truck that rolled over at the end of his road and he is wondering if a citation was issued. He would like the agenda available prior to the meetings. Brian Geisel said he would like to set up a meeting with the other supervisors to discuss additional funding for the fire department. Mr. Geisel does not know anything about the rollover.

Upon further questions, Attorney McConnell stated that the law allows for public comment, but the board has no obligation to answer questions.

Olivia Lazor said when she was a commissioner, there was a work session one week prior to their meeting. If anyone had a question, they discussed it at the work session.

Sheryl Wilson said phone calls aren't returned and questions aren't answered.

Dennis Sump wanted to know the solicitor's wage and how he was hired. Brian Geisel said the solicitor was voted on at an executive session. Attorney McConnell said there is no legal requirement in the Second Class Township Code to advertise and bid for professional services. The solicitor then explained that he is being paid the same as our former solicitor, which is a \$450.00 retainer and a reduced hourly rate of \$90.00.

Chuck Vranich asked the solicitor a question. Attorney McConnell said since it is his first day, he would answer a few questions, but his job is to provide legal advice to the Board of Supervisors. Mr. Vranich asked the solicitor what other townships he served. Attorney McConnell stated he was the solicitor for Mercer County for eight years, he believes he was just appointed as solicitor for Lackawannock Township, and he is the solicitor for Mercer County Joint Sewage Agency. Mr. Vranich asked if solicitors attended meetings in other townships and Attorney McConnell did not know.

Don Morrow talked about an article he read regarding government.

Tom Lyons talked about unsafe water wells in his neighborhood. Brian Geisel and Mark Presley said they looked into a grant last year to extend the water system, and will try again this year.

Joan Rice asked if Berkheimer is getting more or less money for the township than the previous wage tax collector and the supervisors said the township is getting more money.

Rachel Doddato commented that she does not think Tamarack Drive gets plowed often enough and is worried about school buses traveling up the hill.

Roy Masotto hopes that the new board can work together.

Sheryl Wilson said the Citizens Group organized because they felt there was no honesty on the Board of Supervisors.

Bill Klumph asked why the supervisors did not advertise for a solicitor. Attorney McConnell again stated that the Second Class Township Code does not require a township to advertise and receive bids for professional services.

The police, fire, and zoning reports were read.

A motion was made by Brian Geisel and seconded by Rose Lyons to pay the bills totaling \$108,293.58. Motion passed unanimously.

A motion was made by Brian Geisel and seconded by Mark Presley to authorize advertising the regular meeting time and dates for 2014. Motion passed unanimously.

A motion was made by Brian Geisel and seconded by Rose Lyons to adopt a Resolution appointing Black, Bashor, & Porsch as auditors of township accounts for 2013. Motion passed unanimously.

A motion was made by Brian Geisel and seconded by Mark Presley to reaffirm the Sexual Harassment Policy of 06/08/98. Motion passed with Rose Lyons abstaining because she does not have a copy of it and would like to read it first.

A motion was made by Brian Geisel and seconded by Mark Presley to adjourn the meeting. Motion passed unanimously. Meeting adjourned at 7:02 PM.
