## South Pymatuning Township Regular Meeting

The Regular meeting of the South Pymatuning Board of Supervisors was held on May 10, 2017 at 7:00PM in the municipal building with Chairperson Michaelene Harris, Brian Geisel and Rose Lyons in attendance.

The meeting was opened with the pledge to the flag.

A motion was made by Michaelene Harris and seconded by Brian Geisel to approve the minutes of the April 12, 2017 Regular meeting. Motion passed unanimously.

## **Public Comment:**

Ed Wilson asked if Rose Lyons would remain in the office and asked the board to elaborate on the union position being advertised for. Lyons said it would be 12hrs. a week at \$12.00 an hour. He asked if there was any vacation or holidays paid to the union position. Lyons explained there is not. Michaelene explained that the duties of the union position are water billing, payroll, along with other duties. Lyons explained that in the result of a grievance filed and arbitration decision they must fill the union position. Ed asked if the twp. Would be liable if an accident occurred due to deteriorating roads.

Dennis Sump: Asked about the purchase of the dump truck and Michaelene Harris had resident Chuck Vranich speak to the public about the truck to give detailed information. Harris explained that the board will have the fluids changed, brakes, rotors, and any other repairs if needed.

Ruth Bosnjak had concerns about the blocked culvert on Kane Rd. and said she spoke with Burt about it and he refused to unclog it. She said the conservation advised her it was the townships responsibility. She said she paid \$970.00 for a plan and needs the pipe unclogged. Lyons told Ms. Bosnjak that she would not make Burt clean out the culvert until these issues are addressed with the solicitor and conservation.

Don Morrow advised the supervisors to read the township news book and made a statement he is tired of some supervisors just coming to pay the bills and advised to get things moving.

Laurel Alexander asked about the union position and if Rose's hours would be reduced by that amount when it was filled.

Kurt Toth asked who filed the grievance for the union position to be filled. He is still concerned about the ditch not being completed by Penn Dot on Buckeye Dr. He also asked if Orangeville intersection would be milled and Lyons explained it will be resurfaced.

Police and Fire Reports were read

A motion was made by Michaelene Harris and seconded by Brian Geisel to advertise for police officers. Motion passed with Rose Lyons voting no.

A motion was made by Michaelene Harris and seconded by Rose Lyons to purchase a 2009 F-350 dump truck from Stoneboro in the amount of \$14,651.00. Motion passed unanimously.

A motion was made by Michaelene Harris and seconded by Brian Geisel to declare March 12, 2017 as Christian Herrmann Day Resolution 1, 2017. Motion passed unanimously.

A motion was made by Michaelene Harris and seconded by Brian Geisel to accept the resignation of Marsha Bucciarelli effective April 27, 2017. Motion passed unanimously.

A motion was made by Michaelene Harris and seconded by Brian Geisel to advertise for a township officer worker. Motion passed unanimously.

A motion was made by Michaelene Harris and seconded by Brian Geisel to enter a work agreement with Hartford Township to resurface the intersection of Brockway Sharon Rd. Motion passed unanimously.
