

South Pymatuning Township Regular Meeting

The Regular Meeting of South Pymatuning Township Board of Supervisors was held April 10, 2019 at 6:30PM in the municipal building with Chairperson Bill Klumph, and Supervisor's Rose Lyons and Chuck Vranich. Solicitor Charlie Steele was also present.

The meeting was opened with the pledge to the flag.

A motion was made by Bill Klumph and seconded by Rose Lyons to approve the minutes of the March 13, 2019 regular Meeting. Motion passed unanimously.

Public Comments:

Solicitor Steele announced that the reports are complete from the two investigators and asked the supervisors to review them, he said the reports will be released to the ATF and District Attorney first. He said it is a matter of courtesy. Steele said the report will be available under a RTK request within 5 days.

Police & Fire, zoning reports were read.

It was announced that executive session was held on April 4, 2019 for personnel and CBA issues.

A motion was made by Bill Klumph and seconded by Chuck Vranich to approve the bills in the amount of \$106,548.92 and payroll in the amount of \$11,192.36. Motion passed unanimously.

A motion was made by Bill Klumph and seconded by Chuck Vranich to advertise for bids to pave ½ mile of Shadow Dr. to Anchorage Rd. Motion passed unanimously.

A motion was made by Bill Klumph and seconded by Chuck Vranich to enter a paving agreement between South Pymatuning Township and the City of Hermitage. Motion passed unanimously.

A motion was made by Bill Klumph and seconded by Chuck Vranich to advertise for Police Officers. Motion passed unanimously.

A motion was made by Bill Klumph and seconded by Chuck Vranich to accept the reading of the Non Smoking Ordinance and advertise the Ordinance. Motion passed unanimously.

Kurt Toth asked why the solicitor is at every meeting. Klumph said the board asked him to come with all the issues going on. Steele said he does charge for traveling up here and doesn't believe it is necessary to come to every meeting and felt since the reports were being released he thought it would be nice to be able to answer questions anyone might have. Toth asked about Orangeville Rd. Klumph said he is waiting on Penn Dot, and that Ohio is on board with doing their repairs also.

Dennis Sump commended the board for the grants they secured. He said he never remembers the township getting that kind of money. Lyons said the paperwork is not completed yet. She said the paperwork should be in within 30 days and then a meeting will be set up to discuss the projects. Lyons said the grants are approved and fully funded.

Ruth Bosnjak requested a culvert be put under the road on Kane Rd. She said Kane Rd. is whole water shed and put a lot of money of having plans drawn up from an Engineering company. Klumph said it will be addressed with the grant. Lyons said there are approximately 9 culverts that will be addressed. Bosnjak said she would like to thank the supervisors for their service also.

Iolana said she wanted to publicly thank the supervisors in particularly Rose Lyons for addressing the garbage problem on Hunter St. Klumph also thanked Lyons.

Laurel Alexander said she is having trouble getting RTK request. She said she requested copies of the invoices for private investigators and said she only received 2 invoices. She said she received something in the mail for a 30 day extension. She said 30 day extension is against the law. Steele said we are still within the legal time line to answer the RTK and said it is normal to request the 30 day extension. Steele said there has been no legal violation.

A motion was made by Bill Klumph and seconded by Chuck Vranich to recess the meeting until April 18, 2019 at 4:00PM for personnel issues. Motion passed unanimously. The meeting ended at 6:53PM.
