South Pymatuning Township Regular Meeting

The Regular Meeting of South Pymatuning Township Board of Supervisors was held Wednesday, June 8, 2022 at 5:04 p.m. in the Township Building with Supervisors Matthew Chalupka, Chairperson, William Klumph, Johnathan Leyshon and Attorney James Nevant, Solicitor, in attendance.

The meeting was opened with the Pledge to the Flag.

There were 10 residents in attendance.

A motion was made by Matthew Chalupka, Supervisor Chairman, and seconded by Supervisor William Klumph to dispense with the reading and approve the minutes of the Regular and Special Meetings of May 11, 2022. The motion was unanimously approved.

The Police and Fire Department reports for the month of May was presented by Supervisor, William Klumph.

Supervisor Chairman, Matthew Chalupka, announced the building permits – Mabry, 2705 Anchorage Road – Deck; Grove, 4789 Seneca Road – Fence; STG Communication, 3839 Saranac Drive - Generator

A motion to pay the bills totaling \$52,220.51 and the May, 2022, payroll totaling \$39,108.22 was made by Chairman, Matthew Chalupka and seconded by William Klumph. The motion was passed unanimously.

There was no correspondence or old business.

A motion to approve the Brian and Karen Zoccole Conversion Barn Land Development Plan with modification. The South Pymatuning Township Planning Commission has recommended professional security only be provided when the level of attendance exceeds 100 persons. Supervisor, Johnathan Leyshon, seconded the motion and it was passed unanimously.

Matthew Chalupka, Supervisor Chairman, made a motion to approve Resolution No. 9-2022 for Supplemental Appropriations to the 2022 Budget. The appropriations follow – Chamber Steel Service – steel plates for catch basin – Seneca Road and Tamarack Drive (\$444.00); McGill Septic Tank – catch basin – Seneca Road (\$2,008.00); Allegheny Mineral Corporation – stone for double culvert – Kane Road – (\$2,095.99); Greenawalt Excavating – Kane Road double culvert and Seneca Road catch basing (\$17,105.00); Lane Enterprises, Inc. – culverts for Kane Road repair (\$1,494.56); South Pymatuning General Fund – reimburse for Premium Pay (\$14,532.75); A & L Commercial Inc. deposit for salt building new roof (\$9,000.00); A & L Commercial, Inc. – final bill for salt building roof(\$9,500.00). The motion was seconded by Supervisor, William Klumph, and passed unanimously.

A motion to approve an agreement between South Pymatuning Township and IAG Consulting, LLC, an engineering firm, to perform the necessary engineering services for the Township was made by Chairman, Matthew Chalupka. The motion was seconded by Johnathan Leyshon. The motion was passed unanimously.

Supervisor Chairman, Matthew Chalupka, made a motion to hire Jeremie Rupnik as summer help at a rate of \$12.50 per hour. The motion was seconded by Johnathan Leyshon and passed unanimously.

Matthew Chalupka, Supervisor Chairman, made a motion to receive a non-refundable fee of \$25.00 when the public applies for a zoning permit. Johnathan Leyshon, Supervisor, seconded the motion. The motion was passed unanimously.

Residents of 3127 Springwood Drive (Mehallick), 3323 Hummingbird Lane (Papay) and 4178 Stewart Drive (Morrin) voiced concerns about flooding of yards and basements, clogged ditches and mosquitos during heavy rains. Matthew Chalupka stated he would confer with the Township engineer concerning these concerns.

Resident Roger Herrmann asked if any repairs were being considered for Anchorage Road.

Resident Dan Sump asked if line painting was going to be done on Tamarack Drive. Supervisor Chairman, Matthew Chalupka, stated Tamarack and Buckeye Drives will be painted this year.

Matthew Chalupka Chairman, made a motion to adjourn the meeting, seconded by Supervisor William Klumph. Motion was unanimously approved.

The meeting was adjourned at 5:33 p.m.
